NAPHL APPLICANTS

- All applicants must be a full-season Tier I level teams registered with USA Hockey
- Must comply with the rules, regulations and policies of the NAPHL & USA Hockey
- Must stay at approved NAPHL hotels
- Must work in the spirit of partnership with NAPHL initiatives
- Must execute such documents as are reasonably necessary to complete application

Annual Dues: \$2,000 per team, per event

- \$10,000 per team for 18U & 16U teams for five events plus playoffs (5 events total).
- Payable in two installments (nonrefundable)
 - September 15th 50% payment per team
 - December 15th 50% of the remaining payment per team

Application Fee

- \$3,000 due at time of application
 - (Returned if application denied)

Annual Dues:

- Will not exceed \$10,000 per team. (\$2,000 per event)
- Payable in two equal installments on September 15th and December 15th of each year
- Dues are not refundable

Application Process Must Include:

- Application completed in full
- \$3,000 Application Fee (Refunded if not accepted)
